

# Which Councillors to Contact

In order for this campaign to be as effective as possible, it's important that we target the right councillors. The majority of these represent wards outside of Leamington itself, and so may be less aware of the many concerns surrounding the scheme.

## Which Councillors Already Oppose the Scheme?

We understand that the relocation plans are already opposed by all Labour councillors, Bill Gifford of the Liberal Democrats, and Sue Gallagher (who recently resigned from the Conservatives, and now sits as an independent). Writing to these councillors alone is unlikely to help sway opinion against the scheme.

## Target Councillors

At the end of this document you will find a table of target councillors. If your own ward councillors already oppose the scheme (as identified above), you could write to one or more of these target councillors (feel free to also write to them even if your own ward councillors support the scheme). We believe they may be sympathetic to the arguments against the scheme, and may consider voting against it. Try selecting a councillor near your ward, or one your arguments could appeal to.

## Council Executive Committee

Though the decision to proceed with the scheme will be put to a vote by the full council, many other decisions relating to the scheme are made by the council executive (who are heavily supportive of the scheme). The leader and deputy leader claim to have received little communication from people concerned about the scheme, and have said they are happy to answer any questions.
